Upon arriving at the Preeminent lot, I was escorted to the set by a PA. I was given a party dress to change into and a red plastic cup filled with soda. I was introduced to the Subject, an attractive man (who frankly looked too old to be playing a teenager). He apologized to me and thanked me for being there, but I assured him I could handle it. It was a breakup scene, so the Subject yelled at me for a few takes, used some PG-13 language and acted intoxicated. Finally, for a few takes he broke down crying. When he was finished with the scene, he moved like he was going to hug me, but the director – the Client – stopped him before he could. As I was leaving the dressing room after changing back into my clothes, I passed a woman wearing a similar dress. Before I could say anything, she called me *whore* under her breath as she passed me. I have filed a complaint.

Supervisor Notes:

Bearer has been spoken to and is now aware that it is her responsibility – not the Client's – to prevent physical contact from occurring. Bearer has also been advised to retain a professional tone in all future narratives.

In order to immerse the Subject fully in his character, they used tear-away straps to tie me to a bare mattress. They assured me this was cleared with Corporate as well. The Subject pulled up a chair next to me. He didn't yell, he didn't throw anything, which is different from most jobs. He got so close to me – closer than I thought he should, but everything else had been cleared so I just went along with it. He whispered the most horrible things to me – things he was going to do to me or with me. I'm never going to see this movie in theaters. Then he said something awful – I can't repeat it here. I won't repeat it. But I sat up straight and ripped the restraints off and told them to stop everything, that I had to leave. I won't repeat it, please don't ask me to.

The Subject looked at me before beginning the scene, but she didn't seem to be saying lines. At least, not lines meant for an actress. She was talking about me specifically – saying things about my family and my deepest secrets, things nobody should know. I don't know how she knew all these things, these personal and specific things. She told me I was worthless, and that I'd never get out of the situation I'm in. And she's right. You know that? She's right. You must have given her my company files, because she was right about everything. I just sat there, frozen. She got more and more intense, and she threw a coffee cup over my shoulder. A little bit of coffee got on my shirt, but I didn't move. The director – the Client – whispered something, but my ears were ringing and I couldn't hear anything. Before I could react, she reached over and slapped me. Hard. I just sat there while they finished the scene.
